WHEREAS, on April 11, 2023, the Tribal Council adopted Resolution CHO 23-053(B), which authorized conditional relinquishments of MBCI Tribal membership; and

WHEREAS, the Tribal Enrollment Office has received written confirmation that the two subjects of the aforementioned Resolution were enrolled as members of another federally recognized Indian Tribe on February 8, 2023 and May 2, 2023, respectively; now therefore be it

RESOLVED, that the Tribal Council does hereby acknowledge that the two subjects of Resolution CHO 23-053(B) relinquished their MBCI Tribal membership on February 8, 2023 and May 2, 2023, respectively.

WHEREAS, MBCI Reservation lands in the Pearl River Community presently adjoin on all sides approximately ±80 acres of land currently owned and offered for sale by TAMARACK TIMBERCO MS INC and which are located in Section 12, Township 11 N, Range 10 E, Neshoba County MS attached hereto as Exhibit "A"; and

WHEREAS, the said parcel of land is identified as tax parcel number 03700-12-002.000 with the land description recorded in Deed Book 2021 Page 544 of the Chancery Clerk's Office in Neshoba County, Mississippi; and

WHEREAS, additional federal trust lands are needed to accommodate an increase in Tribal membership and to promote Tribal self-determination; and

WHEREAS, the Chairman of the Natural Resources Committee has reviewed this Resolution and has recommended it to be forwarded to the Tribal Council for approval; now therefore be it

RESOLVED, that the Tribal Council does hereby authorize the Tribal Chief to purchase the above said ±80 acres of fee land on behalf of the Tribe for a price not to exceed three hundred sixty-nine thousand five hundred dollars (\$369,500) plus applicable closing costs; and be it further

RESOLVED, that the Tribal Council does hereby authorize the Tribal Chief to submit an application to transfer fee title to the above-referenced private land to the United States of America in trust for the Tribe; and be it further

RESOLVED, that the Tribal Council does hereby authorize the Tribal Chief to sign any additional documents, forms, or contracts directly related to the purchase of the above-referenced private land and its transfer to the United States of America in trust for the Tribe without further Council action.

# A RESOLUTION TO APPROVE A MEMORANDUM OF UNDERSTANDING BETWEEN THE MISSISSIPPI BAND OF CHOCTAW INDIANS AND BCI MISSISSIPPI BROADBAND, LLC D/B/A MAXXSOUTH BROADBAND

WHEREAS, Section 1, Subsection (a) of Article VIII of the Revised Constitution and Bylaws of the Mississippi Band of Choctaw Indians ("MBCI" or the "Tribe") empowers the Tribal Council to negotiate with and to approve or disapprove contracts or agreements with federal, state, or local governments, with private persons, or with corporate bodies; and

WHEREAS, on July 13, 2021, the Tribal Council adopted Resolution CHO 21-112, which authorized applications for grants to fund expansion of broadband service on MBCI Reservation lands and approved a memorandum of understanding establishing the scope of a future agreement under which BCI Mississippi Broadband, LLC d/b/a MaxxSouth Broadband ("MaxxSouth") would deploy its broadband service to all households on MBCI Reservation lands in the Bogue Chitto, Conehatta, Pearl River, Red Water, Standing Pine, and Tucker communities; and

WHEREAS, on April 12, 2022, the Tribal Council adopted Resolution CHO 22-070(B), which approved agreements for MaxxSouth to build and maintain broadband infrastructure on MBCI Reservation lands in the aforementioned communities; and

WHEREAS, on April 14, 2022, the Governor of the State of Mississippi signed House Bill 1029, which established a Broadband Expansion and Accessibility of Mississippi ("BEAM") Fund for the purpose of financially supporting projects that will provide broadband service to unserved or underserved areas of the state; and

WHEREAS, there are MBCI Tribal members residing outside of the MBCI Reservation in areas of central Mississippi that still do not have adequate broadband infrastructure; and

WHEREAS, through their collaborative relationship, MBCI and MaxxSouth have demonstrated the ability to efficiently deploy broadband service in rural central Mississippi; and

WHEREAS, the Memorandum of Understanding attached hereto as Exhibit "A" establishes the scope of a future agreement under which MBCI and MaxxSouth would collaborate to deploy broadband service outside of the MBCI Reservation; and be it further

RESOLVED, that the Tribal Council does hereby authorize the Tribal Chief to sign the Memorandum of Understanding with MaxxSouth attached hereto as Exhibit "A".

A RESOLUTION TO AUTHORIZE FORMATION OF AND TO APPROVE AN OPERATING AGREEMENT FOR CHAHTA LINK, LLC D/B/A C-LINK

WHEREAS, the Mississippi Band of Choctaw Indians ("MBCI" or the "Tribe") is a sovereign, federally-recognized Indian Tribe with inherent authority to create, authorize and regulate corporate entities doing business within the jurisdiction of the Tribe; and

WHEREAS, Section 1, Subsection (j) of Article VIII of the Revised Constitution and Bylaws of the Tribe empowers the Tribal Council to create, or to provide by Ordinance for the creation of organizations, including public and private corporations, for any lawful purpose, which may be non-profit or profit-making, and to regulate the activities of such organizations by Ordinance; and

WHEREAS, on September 1, 2020, the Tribal Council enacted Ordinance No. 16-CCCCC, which establishes a statutory framework governing the formation of limited liability companies as Title XXXV, Chapter 1 of the Choctaw Tribal Code ("Limited Liability Company Code"); and

WHEREAS, the Tribal Council has amended the Limited Liability Company Code through enactment of Ordinance No. 16-IIIII; and

WHEREAS, Section §35-1-5 of the Limited Liability Company Code provides that a limited liability company may be formed by an organizer who is authorized by Tribal Council Resolution to sign and deliver a certificate of formation to the Secretary-Treasurer for filing; and

WHEREAS, there exists a need for the Tribe to form a limited liability company to pursue business opportunities relating to the deployment of telecommunications services and the marketing, billing, and subsidy compliance activities associated with those services; and be it further

RESOLVED, that the Tribal Council does hereby authorize the Director of the MBCI Office of Economic Development to act as organizer for Chahta Link, LLC d/b/a C-Link by signing, certifying, and delivering in duplicate to the Secretary-Treasurer the Certificate of Formation attached hereto as Exhibit "A"; and be it further

RESOLVED, that the Tribal Council does hereby approve the Operating Agreement for Chahta Link, LLC d/b/a C-Link attached hereto as Exhibit "B".
