A RESOLUTION TO AUTHORIZE THE MISSISSIPPI BAND OF CHOCTAW INDIANS' CHOCTAW HEALTH CENTER TO APPLY FOR THE FY 2024 SMALL AMBULATORY PROGRAM GRANT FROM THE DEPARTMENT OF HEALTH AND HUMAN SERVICES, INDIAN HEALTH SERVICE

WHEREAS, Section 1, Subsection (a) of Article VIII of the Revised Constitution and Bylaws of the Mississippi Band of Choctaw Indians ("MBCI" or the "Tribe") empowers the Tribal Council to negotiate with and to approve or disapprove contracts or agreements with Federal, State or local governments, with private persons or with corporate bodies; and

WHEREAS, the U.S. Department of Health and Human Services, Indian Health Service ("IHS") has announced (as attached) that funds will be made available through the FY 2024 Small Ambulatory Program ("SAP") authorized under the *Indian Health Care Improvement Act*, Title III, Sec. 306, P.L. 94-437 (as amended) and codified at 25 U.S.C. Chap. 18, Subch. III, Sec. 1636; and

WHEREAS, the SAP grant is available on a competitive basis for application by federally recognized tribes and tribal organizations for the purposes of construction, expansion, and modernization of small ambulatory care facilities as defined in the Sec. 1636 which service American Indian/Alaska Natives and are operated under a health care services contract or compact entered under the *Indian Self-Determination and Education Assistance Act* ("ISDEAA"), P.L. 93-638; and

WHEREAS, Choctaw Health Center ("CHC") has developed a plan to construct a stand-alone emergency medical services ("EMS") building to relocate CHC's emergency medical technicians and paramedics, their equipment, and ambulances on the CHC campus; and

WHEREAS, the new EMS building will accommodate the growth of EMS' services and staffing, including training areas, additional bays for ambulances, work areas, and storage for equipment; and

WHEREAS, the Tribe can benefit greatly from additional, external resources to construct the new EMS building; and

WHEREAS, this Federal grant opportunity does not require any cost sharing or non-Federal, Tribal matching; and

WHEREAS, IHS will be responsible for 100% of the NEPA compliance costs for all SAP projects; and

WHEREAS, the Tribe is applying for the maximum award will not exceed \$3,500,000, and the deadline to apply is November 8, 2024; and

WHEREAS, the grant funding received through SCEP's Tribal Home Electrification and Appliance Rebates Program will be used for appliance upgrades that will lower utility bills and reduce indoor air pollution in low- and moderate-income Tribal households; and

WHEREAS, the Chairman of the Housing Committee has reviewed this Resolution and is recommended to be forwarded to the Tribal Council for approval; now therefore be it

WHEREAS, the CCF Coordinator is reaching out annually to vendors and to the general public in an effort to increase CCF fiscal resources for the benefit of the Tribe; and

WHEREAS, the Tribal Council authorizes the CCF Coordinator to allocate any additional funds raised from vendor and general public donations to the Choctaw Community Fund without further Council action; and

WHEREAS, the Chairman of the Budget & Finance Committee has reviewed this Resolution and is recommended to be forwarded to the Tribal Council for approval; now therefore be it

RESOLVED, that the Tribal Council does hereby approve the attached Choctaw Community Fund Budget for 2025 in the amount of \$82,635.
